2. The guidelines for project are as under:

- i. To oversee the implementation/creation of infrastructure under the project a "*Committee* on Development of Comprehensive Digital Repository on Millets" under the Chairpersonship of Director (IIMR) has been constituted. The composition of the committee and functions are at **Annexure**.
